Neither of the documents are to be considered as definitive - and both are subject to change. Walking Participants shall include; Club Members, Guests of Club Members and Prospective new Club Members.

| | | Plan the walk for a less busy time, or avoid known busy/popular locations and routes. | |
| | | Remind walk participants beforehand of the guidelines and include those concerning travel and transport. | |
| | Walking Participants and the General Public - through the spreading of Covid-19 | Avoid wherever possible narrow routes where physical distancing is not possible. | |
| The transmission of Covid-19 by close contact with others | | Give clear information re' booking on the walk to limit the group size. | |
| | | Advise participants at the pre-walk brief of the need to maintain physical distancing and that this is their responsibility. | |
| | | Advise participants what to do at pinch points to maintain physical distancing. For example at stiles, gates, road crossings. | |
| | | Advise participants to carry a face mask/covering in case of incidents. | |
| | | Ensure that you have a record of all participants who were on the walk. | |
| | Walking Participants and the General Public - through the spreading of Covid-19 | Advise participants to avoid touching gates and path furniture etc wherever possible. | |
| The transmission of Covid-19 by contact with | | Suggest participants use hand sanitizer and/or wear gloves during the walk. | |
| gates, stiles, fences, equipment etc. | | Advise participants not to share food, drink or walking equipment with others. | |
| | | Advise participants to undertake a full hand wash on returning home from the walk. | |

| | Walking Participants - | Check the weather forecast and postpone/cancel if necessary. Advise walkers to bring suitable clothing and equipment for the conditions. | |
| Extreme Weather Conditions | risk of illness, injury, the group, or an individual, becoming stranded and/or lost. | Have escape routes in mind having identified these during the recce. Abandon the walk and use these as required. | |
| | | Regularly count the group number and discreetly check their condition. | |
| Road Traffic | Walking Participants - risk of injury/death from collision with road traffic. | Advise the group when walking on roads/lanes of the possibility of traffic and the need to walk in single file on one side of the road. | |
| | | When crossing any road where traffic is a possibility choose a suitable crossing point. | |
| | Walking Participants - risk of injury/death from incidents involving livestock. Risk of livestock injury/death and/or property damage if livestock escape. | Advise the group of caution required when entering areas where livestock is present and cross the area in small groups. | |
| Livestock | | Wherever possible skirt around livestock and keep to field edges when livestock is present. | |
| | | When passing through gates where livestock are present appoint a "gate guard" to ensure no animals get through. | |
| | | Close all gates behind you - or leave gates as you find them. | |
| | | Follow the Countryside Code (England and Wales) and Access Code (Scotland). | |
| Steep, slippery or muddy | Walking Participants risk of injury/death from | Check for steep/muddy/slippery sections on the recce and change the route if possible. | |
| sections on the walk | trips/slips | Advise of steep/muddy/slippery sections in the walk description and also during the walk. | |
| | Walking Participants - risk of injury/death from falls | Advise of cliffs/ sheer drops/scrambling in the walk description and also during the walk. | |
| Cliffs and/or sheer drops/scrambling | | Check for cliffs/sheer drops/scrambling on the recce and change the route if possible. | |
| | | If scrambling is involved advice is to be given by the leader or a competent and knowledgeable person. | |
